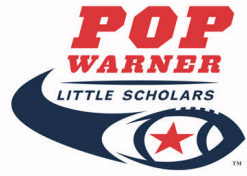

2011 Parental/Guardian Permission and Waiver:

1. PERMISSION TO PARTICIPATE

I, the parent/guardian of the above-named participant hereby acknowledge that my child is in good general health and I give my approval for my child to participate in any and all Pop Warner national, regional, league/conference, association and team/squad activities, including transportation to and from the activities by a licensed driver with proof of insurance.

2. INTENT TO INFORM

I acknowledge that I am fully aware of the potential dangers of participation in any sport and I fully understand that participation in football, cheerleading and/or dance may result in **SERIOUS INJURIES, PARALYSIS, PERMANENT DISABILITY AND/OR DEATH.** Furthermore, I fully acknowledge and understand that protective equipment does not prevent all participant injuries, and therefore I do hereby waive, release, absolve, indemnify, and agree to hold harmless the local, league and regional Pop Warner organization(s), Pop Warner Little Scholars, Inc., and any and all organizers, sponsors, supervisors, participants, and persons transporting the above named participant to and from activities, from any claim arising out of any injury to my/our child whether the result of negligence or for any other cause.

3. EMERGENCY MEDICAL AUTHORIZATION

I hereby grant my permission for any and all emergency medical/dental treatment and/or first aid to be administered to my child/participant, including authorizing any medical treatment facility/hospital to administer emergency treatment, for any illness/injury/accident resulting from participation in any and all Pop Warner activities.

4. EQUIPMENT RESPONSIBILITY

I agree to assume full responsibility for any and all equipment/uniforms loaned to the above named participant and I agree to promptly return, upon request, the uniform and other equipment issued to the above named participant in as good condition as when received except for normal wear and tear. If I fail to adhere to this policy, I will be responsible for the replacement cost of such equipment. I agree to furnish an authentic certified copy of a birth certificate of the above-named participant to local Pop Warner officials.

5. INSURANCE DISCLOSURE

I am aware that my local Pop Warner organization carries group accident insurance which is considered secondary or excess for medical purposes to any and all valid insurance I possess is considered primary insurance. Furthermore, I agree to notify in writing my head coach and local Pop Warner organization of any medical claim as a result of participation in Pop Warner as soon as reasonably possible. I understand that any registration fee paid does not constitute a direct premium for insurance and that a deductible(s) may apply.

6. SCHOLASTIC VERIFICATION

I hereby stipulate that [PLEASE CIRCLE EITHER (a) OR (b)] (a) my child is scholastically fit, or (b) that I have completed the scholastic eligibility form and will adhere to all rules and regulations therein. Furthermore, I hereby authorize my child's school to release school grades, report card results, and any and all other pertinent scholastic information to the local Pop Warner organization in order to comply with Pop Warner's scholastic fitness requirements.

7. FINANCIAL RESPONSIBILITY

I hereby stipulate that I have been advised by the local Pop Warner Organization of my rights, if any, to a refund in accordance with the local organization policies, and I have also been advised of my fundraising obligations for the entire season and agree to fully comply with those obligations.

8. ADULT CODE OF CONDUCT:

S1: In order to uphold the goals of Pop Warner and ensure that all participants have the benefit of a safe and fun learning environment, all parents, guardians and other adults and attendees of Pop Warner events, including but not limited to practices, competitions, and banquets, must behave accordingly in a respectful, courteous and sportsmanlike manner at all times.

S2: Any adult who is using alcohol, tobacco or non-prescription drugs and/or appears intoxicated at a Pop Warner event, and/or who is flagrantly rude, attempts to intimidate, verbally abuse, heckles, taunts, ridicules, boos, throws objects and/or uses vulgarity or profane language/gestures with an official, coach, volunteer, staff member, participant or other event attendee, must receive a verbal warning and/or be asked to leave a Pop Warner event. The member organization may also provide a written warning to the individual regarding the misbehavior. The adult's children may also be removed from the event. Any adult who commits one of the above stated offenses a second time, will be banned from any and all Pop Warner events for a period of one year from the date of the second offense, and their children may also be removed from the program(s) for that time period.

S3: Any adult who physically assaults an official, coach, volunteer, staff member or participant or threatens grave bodily harm may be banned from any and all Pop Warner events for one year from the date of the offense, and their children may also be removed from any and all Pop Warner programs for that same period of time. After the ban has expired, if the individual commits another offense of the adult code of conduct, the individual will be permanently banned from any and all Pop Warner events and the individual's children may also be permanently removed from any and all Pop Warner programs.

RULES & REGULATIONS

I hereby understand and acknowledge that as a parent/guardian of a Pop Warner participant it is my responsibility to comply with all rules and regulations stipulated, adopted or recognized by Pop Warner Little Scholars Inc. or any of its member organizations, including but not limited to the Adult Code of Conduct, stipulated in Section 8 above and published in the Pop Warner Rulebook Any non-compliance with any and all rules and regulations may be cause for discipline and/or dismissal of my child/the participant, myself, and/or any spectators or other persons affiliated with the undersigned and the above named participant.

*The league policy towards un-sportsman-like activity (i.e., fighting, intimidation, kicking, bad language, or disrespect for authority etc. as game officials determine) is as follows:

If flagged for an infraction of this type, there will be a 15 yd. penalty and immediate disqualification from that game. Any player ejected from any game for cause shall be ineligible for participation in their next game. A second ejection during the same season shall be cause for removal from the team for the balance of that season. Game officials and the league will strictly enforce this policy.

*This is a tackle program for eligible boys and girls. The field will be 80-100 yds. And pro-style offense/defense is played.

*This league has a mandatory play requirement. This means that every player on every team will play in at least 10 plays (offense, defense, or combination) in ALL games. These plays can be at anytime the coaching staff chooses and cannot include special teams plays. Coaching staffs are responsible for monitoring their team for compliance.

Registration Procedure

Deadline June 1st, 2011

The required items for registering MUST be submitted together at the same time. Any missing items, including proof of medical clearance, will result in the envelope being sent back. **All completed registration must be mailed and postmarked by June 1st, 2011 to be granted a roster spot (If all criteria is met) any registration postmarked after June 1st, 2010 will assessed a late fee of \$15.00 and a roster spot will be granted if available on a first come first served basis.**

After mailing in your registration items, do not call the league to verify receipt. You will receive a letter from the league shortly after the deadline announcing your acceptance and other league information. All subsequent correspondence will come directly from your child's coaching staff.

ALL of the following items must be mailed to and received by the league no later than June 1st, 2011:

1. **Completed registration/Consent Form**
2. **Nonrefundable players fee - \$115.00** (check, cashiers check, & money orders accepted; made payable to: Duck Creek Pop Warner). Fee includes jersey, which player will get to keep, and rental of all other required equipment except footwear, mouth guard and athletic cup. Nonrefundable after Equipment Pickup Date.
3. **\$125 Equipment Deposit** (SEPARATE CHECK FROM PLAYER FEE please make check payable to the league). The deposit will be retained (will not be cashed or deposited) and returned at conclusion of season upon return of league-owned equipment in proper condition. **No Money Orders for Equipment Deposit.**
4. **Proof of Age** (copy of birth certificate ONLY). DO NOT SEND ORIGINAL. Will not be returned.
5. **Proof of Satisfactory Standing in School** (copy of last report card or letter from school official)
6. **Medical Clearance** A signed statement from an examining physician that the candidate is physically fit and there are no observable conditions, which would contra-indicate him/her playing football. Note: If regular school medical examination was performed after January 1, 2011, and the results are releasable to parents, a copy of such a report may be used. If a physician feels that a physical done in 2010 is still valid in 2011, then a note signed in 2011 is needed. SEE MEDICAL CLEARANCE CARD
7. **Volunteer Application** (Pop Warner requires to annually conduct a background check of: Coaches, Board of Directors members and any other persons and volunteers who provide regular service to the league and/or have repetitive access to, or contact with the players. The purpose of these background checks is, first and foremost, to protect the children).

2011 Registration/Information**

Thank you for your interest in this area's Pop Warner tackle football league. Before proceeding with registration of your child, you **MUST** carefully read, understand, and agree to all of the following general information, even if your child will be a returning player.

YOU **MUST** be a resident of Howard, Suamico, Pulaski, Oconto, Oconto Falls, Krakow, Little Suamico, Abrams, Sobieski, Sampson, Anston, Kunesh, Hobart, Oneida, Seymour or Pittsfield. If you are not, then you are not eligible for this league.

Although subject to final registration totals, the league expects to fill three divisions of play in 2011. A player **MUST** meet the following age/weight requirements to be eligible for this league, **NO EXCEPTIONS! A PLAYERS AGE ON JULY 31, 2011 WOULD BE AGE FOR THIS SEASON.** For example, if you turn 8 after 7/31/11 you are not eligible. If you turn 13 after 7/31/11 you are eligible

The age/weight requirements are absolute. The league will conduct a weigh-in when the player's equipment is distributed, (typically during the first practice, and prior to each game. If a player is 10+ lbs. over or 3+ lbs. under a limit at first practice he/she will **NOT** be eligible to participate in 2011. Failure to meet weight requirements prior to the start of a game will result in ineligibility for that game only. Starting with week 2 of regular season games the weight maximum for each division will increase by 1 lb each week. **THE LEAGUE MONITORS WEIGHT VERY CLOSELY. DO NOT REGISTER IF YOU KNOW THAT YOUR CHILD'S WEIGHT WILL BE A PROBLEM. NO EXCEPTIONS CAN BE MADE. AGE AND WEIGHT REQUIREMENTS ARE SET BY POP WARNER AND ARE MANDATORY OF ALL ITS CHARTERED LEAGUES.** Because weight is a primary factor in determining what division league your child will be placed in, please **DO NOT** guess the weight of your child when completing the registration. Be honest and accurate.

Returning players from 2010 are not guaranteed to be on the same team in 2011 and they must meet the same registration requirements and deadlines as new players. Also, with the exception of sibling and father (coach)-child (player) request, the league will **NOT** accept special requests for team/division assignments or teammates. This includes requests to be with friends or neighbors. The league will structure teams, as it deems appropriate and may eliminate divisions due to low registrations.

*You **MUST** be prepared to attend 4 practices per week for the first 2 weeks and 2-3 thereafter in addition to games on Saturday's throughout the entire season. Chronic and/or unexcused absenteeism will result in dismissal from the league. Furthermore, most (and possibly all) teams will conduct practices in Howard-Suamico. All games will be held at Idlewild Park in Suamico and possible area High Schools.

This season starts **August 1, 2011.** Each player must have a total of 10 hours of non-contact practice time and 10 hours of contact before playing in his/her first scrimmage game on August 13, 2011. Please be aware of this when scheduling vacations the first 2 weeks of practice. Your child may have to sit out a game(s) if hours are not meet.
